Highway Report –Given by Chad

- * The new John Deere loader is here and has been placed in service
- * A demo has been set up with Five Star equipment to showcase excavator and mower for possible purchase in 2027.
- * Detweiler Contracting has been hired to make repairs to garage East wall and repairs to Town Hall roof. The Town Hall roof has water leaks due to heavy rains and ice dam buildup. All panel screws will be checked and replaced if needed.

Supervisor Lewis has heat cable with clips and will be installed when roof work begins

* The Pritchard Rd bridge culvert project will be covered under CHIPS program.

* Damage to the Gradall cab window happened due to bucket coming in contact with cab. No injuries to operator and Gradall is still operational.

* Curtin Farms owner reports that tractor trailers exiting onto Rt 20 from Camp Rd. are having issues with traction. The apron to Rt 20 needs buildup to make exiting more level. Suit Kote will check with suggestions.

* A new dump box ram has been installed on 2017 plow truck

* A new air tank has been ordered for the 2019 plow truck

* The purchase of a new Ford F-600 with plow, wing and sander will be explored. A smaller truck will be beneficial for use on intersections and smaller Town roads. Cost will be approx. \$120,000.00
